Assessment

We charge an hourly rate based on the level of care required, which will be advised after the assessment has been completed.

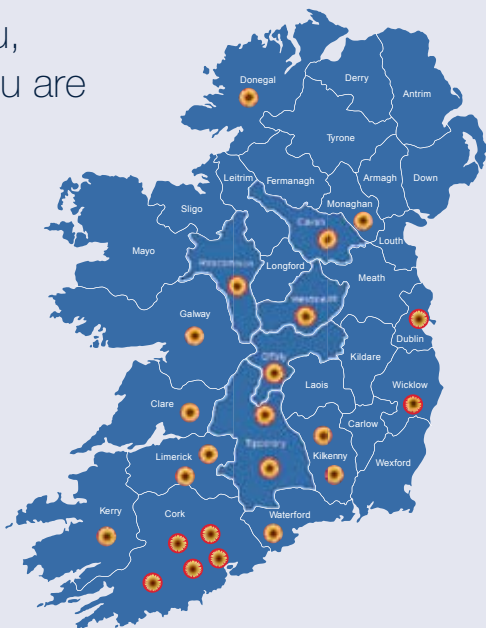
Tax Relief
